RESOLUTIONS FOR CONSIDERATION AT THE EXTRAORDINARY GENERAL MEETING

The following resolutions arise from the report of the Bodychecking Review Committee which was struck following the October 30th, 2011, Presidents Caucus Meeting, and are to be considered at the PCAHA Extraordinary General Meeting on Sunday, January 22nd, 2012. These resolutions require a simple majority for approval.

1. Rules & Regulations – Section E(12 &13), page 88, Bodychecking – “C” Hockey:

Current Wording:

BODYCHECKING:

12. In all games played within the PCAHA, bodychecking in the Atom division and below shall be in accordance with HC Rule 6.2(b) (no bodychecking).
13. In those divisions in which bodychecking is permitted, non-bodychecking “C” league(s) will be offered wherever possible.

WHEREAS the Committee was convened to consider the extent to which bodychecking should continue to be permitted in games played within the PCAHA “C” leagues and **WHEREAS** the Committee considered the various options for changes to the rules governing bodychecking, and **WHEREAS** they also examined what is being done in other districts both within BC and elsewhere in Canada.

THEREFORE BE IT RESOLVED THAT Section E(12) and E(13) be deleted and be replaced with the following:

12. In all games played within the PCAHA, bodychecking in the Atom division and below and in all “C” hockey shall be in accordance with HC Rule 6.2(b) (no bodychecking).

- 13. In those divisions in which bodychecking is permitted, non-bodychecking “C” league(s) will be offered wherever possible.

AND BE IT RESOLVED THAT Section E(12) be amended to state that bodychecking in PeeWee “A” shall be in accordance with the HC Rule 6.2(b) (no bodychecking).
